A resident presented a letter requesting permission to erect a marquee on The Green for a party. The applicant has hired The Cade for the event. Cllr Herring queried the possibility of noise nuisance, it was suggested that The Cade check their music licence and advise of terms when confirming the booking. It was further requested that the applicant advise neighbouring property of the event date and times.

Clerk to confirm agreement to the request subject to:

- Proof of public liability insurance.
- Written agreement to make good any damage to The Green.
- Confirmation that the marquee will not be erected if on the day there is a high wind.
- Neighbouring properties being advised of the event.

84. District and County Councillor Reports

To receive verbal reports from district and county councillor.

County Cllr M Smith confirmed that the planeings have been delivered to Caxton End. A price for the replacement bollards is awaited and will be sent once received. There has been no further correspondence from S Greenfield following the A428 meeting. As the action points from the meeting have not been actioned Cllr Smith will follow up.

Cllr Pinner confirmed that he had logged a comment on the East West rail consultation on behalf of the Parish Council supporting the southern route 'A'. The Clerk asked if there was any update on the rerouting of bridlepath adjacent to 14 St Neots Road on the rights of way register. Cllr Smith will follow up. Cllr Pinner asked that the path alongside B1040 be sprayed for weeds. He also asked if it would be possible for more repeaters to be installed as part of the traffic calming measures.

District Cllr M Howell offered Cllr N Wrights apologies. He confirmed that the District Council are supporting the Northern route for the East-West rail link which takes in Cambourne.

There is a change in policy for council tax relating to empty housing.

Heide Allen MP is now independent having left the Conservative group.

Cllr Cropley asked if a report he had heard regarding the dumping of rubbish into landfill rather than sorting and recycling was correct. Cllr Howell will look into this but he had no knowledge.

Cllr Pinner asked again if he could follow up a replacement bin for The Green by the bus shelter.

(ii) Village Drainage

Cllr Pinner updated Council following the last meeting with residents. As it is not possible for the resident who had offered assistance to obtain public liability insurance the decision now is whether residents get a quote from the Council contractor and whether another meeting is required.

It was agreed that the meeting should wait until the Parish Council has completed the ditch work which is due to start shortly.

(iii) Pond by the School

Cllr Herring spoke stating she was waiting a reply to the letter sent to Parish Council. Cllr Pinner confirmed that the Council were waiting for a date for a meeting. Cllr Herring confirmed this will be forthcoming once she has met with her solicitor. Cllr Pettifor confirmed that the aim is to reach an amicable solution.

(iv) The Green- bollards

Cllr Pinner confirmed prices from Glasdons ranging between £90 (concrete) and £120 for timber. Cllr Pettifor expressed a preference for wood. Cllr Weldon asked if the new bollards could have some form of reflector on them.

Cllr Pinner also provided a mock up sign 'no parking' which he will now get prices for ready for the next meeting.

(v) Cambs Water – The Green water bill.

Cllr Pinner thanked the Clerk for resolving the issue of the £960 water bill inherited from the cricket club, it was confirmed that this has been cancelled.

Clerk confirmed that the standing charge for a year is £31.50 plus VAT so it was agreed that the Parish Council will now take over the account. The Clerk will advise the company of the correct account details.

(vi) Cricket side screens.

Cllr Pinner confirmed that the cricket club have found a club in Bassingbourn who would like the screens. Cllr Pettifor felt that the club should be mindful of any history to the screens and advise residents of the matter. Cllr Lines suggested a notice be posted by the club for a 2 week period.

(vii) RoSPA play area report

Cllr Pinner confirmed that the wobble board had been removed for repair.

The next village working party will remove the stepping log that the report identifies as a hazard, they will also deal with the wall at the back of the hut and the lose bolt on the swing.

(viii) Goal Post.

Cllr Pinner advised that the part in question is being made and will be installed in due course.
